The information you requested for this year, insofar as it is held (noting that the current undergraduate applications cycle is ongoing), is exempt under section 36(2)(c) of the Act because its disclosure would be likely to prejudice the effective conduct of public affairs, in this case the integrity of the College's applications and admissions process which form a fundamental part of its mission as an educational institution. (As the information requested is statistical in nature, the opinion of the qualified person did not need to be sought for this application of section 36.) The current undergraduate applications cycle is ongoing and applications are still being submitted and assessed. The College considers that the disclosure of detailed statistics about applications made within the current cycle would be likely to prejudice the notion of a fair and confidential admissions process whereby each applicant has the same information at their disposal and partial granular data is not disclosed to specific members of the public while the process is ongoing. As this is a qualified exemption, the College has considered whether, in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information. The College considers that, while some people might have an understandable private interest in these statistics, there is no genuine public interest in them when set against the extensive statistical information available about previous admissions cycles published https://www.undergraduate.study.cam.ac.uk/apply/statistics, coupled with the prevailing public interest in maintaining a level playing field in terms of the information available to all applicants.

1) Do students that, due to isolation, are forced to stay beyond their licence expiry/planned leaving date need to pay rent for the additional days?

No

2) What is the reason for the above policy?

Our policy throughout this year has been to charge rent for any time spent in our accommodation, including additional days beyond the usual period of residence and with financial support available in cases where this extra rent causes hardship to our students.

After careful consideration, I can confirm that the College will not charge rent at the end of this academic year where a student remains in accommodation for additional days beyond their license period for the purpose of self-isolation — this is offered as a goodwill gesture reflecting exceptional circumstances at the end of Easter Term. We do appreciate how challenging this year has been for our students and recognise that the coincidence of the spike in cases locally and end of term plans is exceptionally frustrating for all involved.

If a student has reason to remain in College accommodation after the isolation period ends, this will require the College's agreement and rent will become chargeable again.

3) Other than rent, does your college have any financial support applying to isolating students, e.g., a food discount?

Thank you for your request for information.

Donations to St Catharine's arrive in many different forms and for the purposes of this exercise, I would like to clarify that the definition of "donations" used in this response excludes legacy gifts. Unfortunately the majority of donations to the college are not permitted for disclosure based on the section 40(2) exemption relating to the personal data of others. We cannot disclose individual donors and donations to St Catharine's College, because we do not have permission from individual donors to disclose their donation and its purpose, publicly and it is probable that most donors would find it surprising if we did disclose their donations in this way. We are also mindful of the Fundraising Code issued by the Fundraising Regulator which states in standard 3.1.5:

You must meet any duties you have to keep data confidential.

You **must not** share data if you have a legal duty to keep the data confidential, unless there is an overriding legal reason to do so. For example, if a court ordered you to release the data.

Due to the severe shortage of residential parking in Cambridge, undergraduate students are not usually permitted to possess a car in the city. The College has limited parking available at its graduate residences for students who have a medical or academic need to use their car. They will need to apply on our website. Parking at Russell Street and Chesterton Road are solely for students living at those residences. There is one space at Chesterton Road and five at Russell Street but these are mainly for housekeeping and maintenance.

- 2) What is the distance in miles from the halls of residence to the main university campus? Please also list the distance between your nearest halls of residence to each campus.
- First and third year students live on the College's main campus in the centre of Cambridge.
- All second years live in St Chad's flats 0.7 miles from the College's main site.
- Postgraduate students can chose to live in private accommodation or in our graduate accommodation:
- Russell Street 1 mile from the College
- Barton Road 0.8 miles from the College
- Harvey Road 0.9 miles from the College
- Fitzwilliam Road 1.4 miles from the College
- Coleridge road -2.0 miles from the College
- Grantchester Meadows 0.9 miles from the College
- The Vicarage on South Green Road 0.9 miles from the College

0118 – Land ownership

This is a request for information under the Freedom of Information Act (2000) and Environmental Information Regulations (2004).

Under the Act and Regulations, I am requesting release please of the following information:

- 1) A GIS (digital) map of all lands and properties owned by your college (freehold and leasehold), ideally released in Shapefile format, or if that format is not available, in any available GIS file format.
- 2) If release of (1) is not possible, I ask please that you release an Excel spreadsheet listing all lands and properties owned by your college(freehold and leasehold), including details of a) land areas for each site (acreage/hectares) and b) locations of each site (whether postcode, OS grid reference or eastings/northings).

'Land' is environmental information under the terms of the Environmental Information Regulations, and has been recognised as such by, for example, a number of water utilities who have released land ownership maps under the EIRs.

To anticipate refusal to release this information on grounds that it is already easily publicly accessible via the Land Registry, this is absolutely not the case. A PN1 search request of the Registry, even if the registered legal name of the landowner were easily known, costs £11 per search for each entity and



does not result in a GIS map of findings. The Land Registry refuses to release information allowing the linking of land title numbers to INSPIRE ID polygons, thereby rendering it impossible to build up a map that way. Purchasing land titles and plans for every field in England at £3 per land parcel, hoping to occasionally hit upon Oxford college land, would soon bankrupt any investigator. So this information is not easily publicly accessible and this exemption under the Act and EIRs cannot apply.

There is a very strong public interest in seeing the release of this information, for purposes of improving public understanding of who owns land, and the impacts this has on a multitude of issues, from how land is being used to help or hinder the climate and ecological crises, through to house prices and social inequality.

- There was one undergraduate student in 2018-21 and one postgraduate student in 2021-22. Both were/are intermittent users of a wheelchair.

St Catharine's College is undergoing major refurbishment works at the moment, which includes



improving accessibility via creating more level access, introducing a lift to navigate our central spaces and introducing specifically designed accessible bedrooms, both on our main site and in our 2nd year accommodation. We currently have two accessible rooms at our main graduate accommodation block on Russell Street.


