Description of Task:	As the College community enters another period of increased national restrictions, it is imperative that students are provided with safe spaces within College where they can socialise and interact with their household. From the start of Michaelmas term the welfare team have noted an increase in students who are choosing to spend more time in their rooms, both to study and to relax, leading to an increased sense of isolation. This isolation is negatively impacting their wellbeing as they do not have a strong a sense of connection and belonging in the College community, lowering resilience and increasing their chances of mental ill health. In providing space which is well managed and robustly cleaned, students will have the opportunity to spend time interacting with their peers and partaking in fun and energising activities. This will provide significant benefits for the emotional wellbeing of the students as they will be able to have a change in external environment and have the chance to foster the social connections which are vital for individuals to thrive. Recreational areas shall be limited to: Wolfson Court, McGrath Centre, JCR, Octagon, Sherlock Court, Masters Garden, St. Chads lawn, South Green grounds and Russell Street lawn. All students attending must be from the same household. Sessions are bookable through the online booking portal overseen by the Conference Department. Sessions will last 1 hour and a 30 minute gap will be blocked before the next booking slot is made available to students.

The conference team must check the college isolation register prior to confirming bookings so to as not unknowingly allow a student to participate who is in isolation.</li> <li>Students arriving and leaving recreational activities must social distance themselves from others within the College Community and wear face masks as per College policy, until they are back in their households.</li> <li>Bookings allow for a 30 minute gap between sessions to reduce the risk of students crossing paths with other households when arriving and vacating recreational areas.
